The California Constitution (Proposition 13) requires the Assessor to reassess real property each time a "change in ownership" occurs. A "change in ownership" means a transfer of a present interest in Real property.

A reassessment may result in increased property taxes. However, you may be able to avoid an increase, if the transfer referenced above qualifies for an exclusion from reassessment according to the following.

California Revenue and Taxation Code Section 62 (a) excludes from reassessment certain transfers of real property between an individual and a legal entity (such as a partnership or corporation), or between legal entities, when the transfer changes only the method of holding title, and the proportional interest of the transferors and transferees remains <u>identical</u>. For example, when A and B transfer their 50% undivided interests in real property, to a partnership in which each of them have a 50% partnership share.

In order for the Assessor's office to consider an exclusion from reassessment for your transfer, you must apply for the exclusion by filing the Affidavit of Entity Transfer on the other side of this letter. If you are unable to return the form within 10 working days, please call us or send a note of explanation.
